To whom it may concern:

I've been using parts of your excellent SAM software package as components in my lineage assignment system for viral evolution here at CDC. I'd like to publish and distribute my method, which includes a few of your binaries in the pipeline. In particular, I use: "hmmscore" and "modelfromalign", although foreseeably "buildmodel" could come in handy one day.

The SAM software would be a part of a larger package resource folder and would include all and any license information. I can include just the components I need or the entire SAM package if requested. I use both Darwin & Linux versions of SAM. SAM would also receive proper citation given any publication of my method. SAM would also be credited in the documentation with links to your website.
Specifically, I would like to make my system available via web interface as well as for download.

Please let me know what permissions I may or may not be able to obtain for the listed SAM components and for what conditions.
